Help for Hurricane Harvey DKG Member Victims

In addition to donations to the DKG Emergency Fund, individuals and chapters may donate money directly to the Texas State Organization whose members' schools have been devastated by Hurricane Harvey. Please read a portion of an email from Cookee Johnson, Golden Gift classmate of our own Beverly Smith and state coordinator for Campus Helping Hands Donation for Texas members and their schools.

First, we have been told by numerous sources that school supplies are not needed or wanted at this point. Wal-Mart, Target, and other major retailers have been very generous with supplies to students, and schools are asking at this point, not to send any more.

Second, I guess that the schools we are hearing from have told me that, at this point, they are not in a position to partner with anyone yet. Too much to deal with just because of the enormity of the recovery process and too much to keep up with right now. Maybe in the not too far future the schools might be in a good place to do that.

What I am being told by principals is that they need are funds to purchase equipment and items not currently available to them due to water damage and general destruction. I think that money is the most reasonable request so that the schools can purchase what they most want and need to get back to some normalcy.

So I suggest that members send their donations to the chapter treasurers and then write one check with the total donation. I am attaching the form we are using and ask the president or treasurer to fill it out and follow directions in the red notation. Because this is the time when member dues are sent to headquarters, the state president has asked that the campaign checks be sent to me at the address I have at the end of this email. I am the state coordinator and I need to keep records of who and what is sent for this campaign. I will send on to headquarters for deposit and once the donation has been allocated, I will use the form to let you know where the money will be used.
